- A. Mayor Duane Pouder opened the meeting at 6:00 P.M.

G. Project:

Heath Riffle from Mote and Associates updated Mayor, Council and Residents on current projects.

Street Department Building

1. Gas and power services are completed to the old building.

2. There is an issue with the property line. Derek Brim offered to sell the property adjacent to the Village for \$18,000.

3. Councilman Eric Rust recommended to meet with a contractor to discuss pricing for a firewall to go around the lot.

Water Treatment Plant

1.. The project did not score well enough for grant funding due to having access to treated water. Heath recommended getting a letter from Union City Indiana stating they can shut the Village's water off at anytime if they have issues. Our water resource is also causing flow pressure issues with our fire hydrants.

2. Heath also recommended a water rate increase for the village citizens, or putting on a levy to help pay for the treatment plant.

Waste Water Treatment Plant

1. The suction line for the irrigation is drawing in fish which in turn is blinding off the screen before irrigation system. The pumps are designed to pump 600 gallons per minute (x4 pumps). Pumps are deheading against screen when it is blinded and they are only pumping 400-500 gallon per minute with two pumps on. The pumps were rebuilt last year and this is a lot of wear and tear on them.

2. The repair process is to locate the 12" irrigation suction inlet. Coffer the dam and pump down dam area or reroute flow to pump one lagoon down at a time. Install new beehive grate or floating decanter. Install lagoon level staff gauge. Remove coffer dam.

Detention Basin

1. The fence final grading and seeding to be completed in the spring. The pipe and flow channel is complete. Heath recommended adding a swale.

2. There is a change order for adjustment for excavating quantities, and a pay application for Tom's Construction.

Sanitary Sewer Rehabilitation Phase V-15" WWTP Influent Leaks @RR

1. The options are pipe patch for \$4220, lining \$18,000 or open cut 37' deep for \$85,000. Heath is going to get a hard quote to line for the January meeting.
