Councilman Brad Horsley motioned to excuse Councilwoman Nicole Whitesel from the meeting. Councilman Eric Rust seconded. The voice vote passed unanimously.

Councilman Brad Horsley motioned to consent of agenda and Councilman Zachary Pruitt seconded. The voice vote passed unanimously.

F. Village Citizens:

Rick Reichard spoke to council about issues with facebook comments on the job they did plowing the streets during the last winter storm we had. He spoke on the countless hours they were out trying to keep the streets travelable. The street department is asking all citizens to remove cars off the streets, especially in the cul-de-sacs in order to be able to maneuver the plows around the streets. Councilman Eric Rust told him he thought they did a great job and it doesn't matter what they do, there will always be someone not happy and if they have complaints they need to come to a council meeting and discuss it with council if they feel something isn't being done correctly.

Dick Root from Darke County Contractors came to discuss a drive up window for the administrative office. He gave a quote for the window and installation of \$2,000. He said it would be a two day job. Council agreed to table it until the next meeting.

Chad Henry from Choice One Engineering out of Sidney Ohio came to the meeting to offer Engineering Services to the Village and asked to be considered for any future projects the Village will need an Engineer firm for.

Homer Stammen discussed issues with 902 E Elm St. Steven Fourman addressed him about turning his used appliance store into duplex apartments. Homer gave him the okay because it is zoned a B3, Neighborhood Business District but Spectrum is saying they can't get services there because it is not zoned for residential services. Councilman Brad Horsley recommended calling a zoning meeting to get the zoning straightened out.

Heath Riffle from Mote & Associates gave the following updates:

- 1. Pay application for \$24392.10 to Tom's Construction for regrading around the detention basin. Councilwoman Robin Meinerding motioned to pay Tom's Construction in the amount of \$24,392.10. Councilman Eric Rust seconded. The voice vote passed unanimously.

The Street Department barn- The Village needs to either have the property surveyed to make sure the barn is at least five feet from the property line or has a 2-hour fire wall installed instead of a 1-fire wall.
