Councilman Eric Rust motioned to consent of agenda and Councilwoman Nicole Whitesel second. The voice vote passed unanimously.

F. Village Citizens: Village citizen Homer Stammen spoke and stated council needs to keep moving on the progress of the water treatment plant. He stated the water pressure is very low.

Ohio Valley Gas talked on the plan of North Street. They need to install new gas lines down North Street. Councilman Eric Rust stated he is not happy about this plan because before the Village put all the money into North Street Ohio Valley Gas was notified and asked if they had any plans in the near future to do this project so we could hold off on the new street so it wasn't going to get tore up after the village put the money into it and Ohio Valley Gas said they did not. Ohio Valley Gas stated they will try a directional bore to keep from cutting into the new street, but that's not a guarantee they can do it this way. Another possibility is putting a gas line down both sides of the street or in the alley if possible. If they do have to cut into the new street they will have a company come in and cut it out, put in a base they top with cement and black top it. Council asked if the patch work does not hold up, who is responsible for the repairs to it. Mayor Duane Pouder said we will schedule a Street Committee meeting with Ohio Valley Gas and discuss some options.

Ohio Valley Gas also stated they need to install a regulator on the corner of North and Division. It will be a three foot by four foot hole. They will make sure there is a patch over it, even if temporary, before winter.

G. Project:

Darren Reeves from Mote and Associates brought a quote for services to update a 10 year plan. If council signs the contract Mote and Associates will look at all the roads and do the work in two phases, chip seal first and then move on to full depth reconstructions. It will be a couple weeks before they could start and the Village will probably not get anything done this season because it's getting too late in the season and all the paving companies are booked up with other projects.

Chad Henry from Choice One Engineering talked to Council about some of the options Choice One Engineering could offer. He provided an outline of the projects we have discussed. He says the Village should check into RCAP which is a non profit organization that would be very beneficial to the Village for water independence. Chad also stated he would like to be involved in a Street Committee meeting to see what is important to the Village.

Jim Smith from Smith General Contracting stated his crew will start on the Fire Department on Friday September 9, 2022. His crew will be picking up the brick for the Fire Department on Thursday morning, September 8, 2022. The street department building is still waiting on the metal. Once all the studs are up for the walls, Shockney Electric will come in and put in all the electrical boxes in the walls and ceiling. Council agreed to start the Fire Department on Monday, September 12, 2022 because Mr. Smith stated it will take approximately four days to complete. Mr. Smith stated the reason the deadlines have not been met is because supplies have been on backorder. Councilman Eric Rust stated Mr. Smith needs to communicate with the Village and let them know the status of each project.

Mike Bowers from Darke County Economic Development would like to be updated on the projects to see if there is any help they can be to the Village. He would like to see the list Chad from Choice One gave the Village. EDA could open up a little bit of funding to help.
